

Paediatric and Perinatal Epidemiology... in the Spotlight

We are pleased to write about *Paediatric and Perinatal Epidemiology*, a Journal affiliated to SPER, and share a few new initiatives in this issue of SPER's newsletter. At the SPER business meeting in June last year, we discussed the benefits of strengthening ties between PPE and the SPER membership. Being in touch through the Newsletter is one way to do this. The Journal is doing well, but a status quo is not good enough! A first initiative is to produce several special issues on high priority topics in reproductive, perinatal, and pediatric epidemiology. After a call for proposals, we selected the following 4 through a competitive bidding process:

- Maternal health, co-edited by KS Joseph and Marian Knight
- Leveraging innovative technology to enhance research in reproductive and perinatal epidemiology, co-edited by Lauren Wise and Courtney Lynch
- Prenatal exposure to acetaminophen and childhood neurodevelopment, co-edited by Samantha Parker and Martha Werler
- **Predictors, outcomes, and classification methods of periviable births**, co-edited by Sarah Keim and Courtney Lynch

In response to comments by our readership, we have extensively revised the author requirements for the journal. This was done to simplify the submission process. Importantly, we have instituted a "flexible submission policy" where authors are free to submit manuscripts that do not strictly adhere to the new guidelines at the initial submission. However, if a manuscript is considered further (i.e., a revision Is recommended), we will ask authors to format the manuscript following the Journal's new guidelines.

We are pleased to welcome Courtney Lynch as a new associate editor and Samantha Parker as trainee editor, working with Sarah Keim. We are always looking for trainees interested in perinatal epidemiology and epidemiologic methods. If you are interested, please jot us a note. We have recently re-structured PPE's editorial board (thanks to Jennifer Zeitlin, our deputy editor's efforts!). 2019 Award Nominations

Student Prize Paper Award (due Mon, March 4)

SPER requests manuscript submissions for consideration for the annual Student Prize Paper Award. This competition is open to graduate and medical students, postdoctoral fellows, medical residents, research trainees, and clinical fellows interested in reproductive, perinatal, and pediatric epidemiology. The winner of the award will present the selected paper at the SPER Annual Meeting. An award of \$500 plus expenses for travel, two days lodging, and SPER Annual Meeting registration will be given to the author of the selected paper.

Mentoring Award (due Mon, March 4)

The SPER Mentoring Award recognizes the importance of dedicated and skilled mentors in the development of reproductive, pediatric, and perinatal epidemiologists at all levels. The nominees will be evaluated based on proficiency in mentoring skills, dedication to mentoring, and attention to advisee development technically, professionally, and personally in the field. Nominees should demonstrate effective people skills, motivate and inspire their mentees to excel, and should serve as a role model, teaching and demonstrating high standards of performance and integrity. A \$500 prize is awarded.

Rising Star Award (due Mon, March 4)

This award is to recognize early to mid-career investigators whose achievements and potential set them on a trajectory to become research leaders in the field of reproductive, perinatal, and pediatric epidemiology. Overall research contributors thus far, including publications, presentations, and influence on the field will be considered. An additional important consideration is the candidate's likely future role, as their career continues to evolve. SPER registration will be covered for the winner and a \$500 prize is awarded.
