In the feedback on the 2023 Annual Meeting, people raised a wide range of topics that they would like to see represented at future meetings. All suggested topics would be welcomed. There are 3 ways that you can help promote a topic of interest: 1) submit a symposium proposal (deadline page 4), 2) submit and encourage others to submit relevant abstracts (deadline page 4), and 3) volunteer for the Program Committee. Symposia are sessions focused on a specific theme. They often cover emerging topics, controversies in the field, or topics that have been underrepresented at the Annual Meeting. When proposing symposia, it is helpful to define what the interrelated talks would cover and list potential speakers. We welcome symposium proposals from trainees as well as more senior SPER members. You can learn more at SPER symposium submission.

I am excited to share that we are planning a Virtual Meeting that will take place this Spring. Please watch your e-mail for more information including the abstract submission deadline!

Starting on page 2, you will find a question and answer (Q&A) section that addresses feedback from the 2023 Business Meeting and the post-meeting survey. The questions addressed are only a sample of the topics raised, but we are considering all feedback that we have received. If your question has not been answered here, feel free to reach out to me or other members of the Executive Committee.

2024 Annual Meeting-Related Q&A

- 1. I have concerns about traveling to Austin because of Texas laws related to reproductive healthcare or LGBTQIA+ rights. Can SPER change the meeting location?
 - Meeting contracts are signed 5 to 6 years in advance of a meeting, and the financial penalty for canceling the contract is prohibitive so we cannot change the meeting location.
- 2. If I do not attend the 2024 Annual Meeting, are there other ways that I can participate in the conference?
 - Yes, we are planning our first ever Virtual Pre-Conference Meeting in the Spring! People will be able to submit abstracts specifically for the virtual meeting. We will send more information soon.
- 3. Could SPER live stream Annual Meeting?
 - We explored this option and obtained a quote from the vendor. To cover the extra costs of live streaming the meeting, we would have to significantly increase the meeting registration fees while also charging the online attendees the full registration fees. The increased costs would

likely mean fewer people would be able to afford to attend the meeting. Therefore, we are not planning to live stream the meeting this year.

- 4. If live streaming is too expensive, could SPER record the Annual Meeting instead?
 - Although it might seem that recording the meeting would be a more economic option, the cost of recording the meeting is greater than the cost of live streaming the meeting because the same equipment is required and then there are additional expenses related to posting the recordings.

2023 Annual Meeting Survey Feedback-Related Q&A

- 1. Can we include pronouns on name tags at future meetings?
 - Yes, absolutely!
- 2. Will gender neutral bathrooms be available at future meetings?
 - We are contacting the hotel to see if this is possible.
- 3. Will there be a lactation room at future meetings?
 - We are contacting the hotel to see if this is possible, and we will discuss the specific issues raised in the post-meeting survey about the lactation room that was available in Portland.
- 4. Will there be captioning of talks at the Annual Meeting?
 - Unfortunately, captioning talks at the Annual Meeting in Austin is currently cost-prohibitive. However, we will continue to evaluate this going forward.
 - We do expect captioning to be available for the Virtual Meeting
- 5. Are sessions on [insert topic of interest to you here] welcome, and if so, why aren't there any?
 - Yes, a wide range of topics are welcome.
 - Most of the program is based on member submissions. If you would like to see a topic presented, we encourage you to submit a symposium proposal or abstract.
 - You can learn more by volunteering to be a member of the Program Committee. Watch for an email asking for volunteers!
- 6. Can you make the lunchtime poster session more prominent?
 - We are exploring other times for the 2^{nd} poster session this year.
- 7. Why don't we have more international and/or DEI travel awards?

- 8. When the NIH R13 is renewed, why don't you add more money to cover a virtual meeting or to cover more travel awards?
 - The NIH R13 grant only provides \$6,000. We use this money to fund the travel of the winners of the Heinz Berendes International Travel Award and the Student Prize Paper Award as well as the cost of the poster display boards. Maximizing the number of poster display boards is important because it increases the number of people who can present at the conference.
- 9. Can the annual dues be aligned with the date of the conference?
 - We have explored this issue in the past, and unfortunately, there are fiscal reasons that this is not possible at this time.
- 10. What opportunities are there for networking?
 - We launched a Welcoming Peer Program a few years ago, which matches new attendees (not limited to first-year attendees) with long-term members to facilitate networking.
 - The poster sessions are great times to meet people and talk about their research.
 - We are also exploring the possibility of adding virtual and/or in-person networking sessions this year (e.g., bringing back the breakfast roundtables).
- 11. Why doesn't SPER have a late breaker session?
 - Unfortunately, we do not have enough sessions to accommodate a late breaker session.
