President's Corner

As I prepared to write the President's corner for our Fall 2025 SPER Newsletter, I reviewed past Fall newsletters. All of them reflected on the Annual Meeting, our society's hallmark activity, and expressed appreciation and thanks to all who worked together to deliver this opportunity for learning and networking with colleagues. I too want to recognize our Annual Meeting in Boston and the work that went into making sure it was inclusive, accessible, and filled with the very best science in our field. Thank you to the program committee, poster presenters, plenary



speakers, symposia organizers and speakers! SPER is you and you are SPER. Everything we do is dependent on the generous time given to us by SPER members and committee members as well as those who were elected to serve – our committee chairs and our Executive Committee. Finally, congratulations to all our awardees!

Some of you stayed on for the Business Meeting and we had a chance to talk about the challenges we are experiencing in 2025. Our focus was on developing a statement from our society. I haven't forgotten about that discussion! Yet we are all aware of the speed and volume of what scientists, especially reproductive, perinatal, and pediatric epidemiologists, are facing. Many attendees raised the need to go beyond words and take actions. Many of you are taking actions as human beings and as scientists.

What then can we do as SPER? First, unlike in many crises, we can speak to the public about the many health topics in which we are experts. Just in the past few weeks, our communities heard misinformation about autism spectrum disorders. I am asking all of us to be open to speaking directly to our communities and to journalists. Start working on summaries of your work or your interpretation of current controversies so you are ready when you get an email or text. I'm not naïve but I am hopeful that we can give the public a reason to trust us. Many of you are tapped by journalists reaching out to your workplaces, but we can also use SPER to

provide journalists a list of epidemiologists who will speak up. More on this soon! Please email me (misradaw@msu.edu) if you would be interested.

We also need to act locally. It can be much easier to speak to journalists from national publications who have steeped themselves in the topics. But what about your city, county or state? Check out the Substack "Your Local

Epidemiologist" for an approach to taking the initiative. You can contact your local journalists or be open to answering when contacted.

How can we support the many amazing federal and state scientists who have lost their jobs? And what about those whose careers may fail to launch because of constrained research budgets and fear of the future by institutions? Few of us are in a position to provide our colleagues with a job. But we can listen, we can invite them to give talks at our institutions, and to teach guest lectures. We can also share our intellectual resources. Inviting these colleagues to attend our lab team meetings or seminars may provide a lifeline – not everyone will be interested but please consider reaching out to find out. If you are one of the affected researchers, don't be shy about sharing your expertise! I speak from experience. Activating my networks and reaching out to friends sustained me during a difficult time in my career.

Some of you are also uniquely vulnerable at this time, by nature of your gender identity, racial identity, immigration status, or employer. You may belong to a group that cannot publicly speak up but I hope that SPER can provide a platform for speech that supports your work and identity.

Finally, we all know the importance of epidemiologic data. One of the most dangerous things to have happened this year has been the disappearance of existing data sets, along with the pausing of programs to collect new data. Without such data, public health workers and policy makers make decisions in the dark. I have been talking with colleagues about how we can help PRAMS to continue to produce data that can be shared across all states in the U.S. I am exploring how SPER can strategize with the Association of MCH Programs (AMCHP) to find a way forward together. Executive Committee Nominations due March 13, 2026

Nominations are being sought for President (2026-2029), Treasurer (2026-2029), one Member-at-Large (2026-2030), International Representative (2026-2029) and Trainee Representative (2026-2027). All terms will begin at the close of the June 2026 Annual Meeting. Members of SPER are encouraged to nominate themselves or any other member of SPER to run for these positions and help our Society achieve continued success through this opportunity for professional service.

The President will serve as President Elect (2026-2027), President (2027-2028), and Past President (2028-2029). The main duties of the President Elect are to help the President develop plans for the Annual Meeting, organize and develop the plans for the Virtual Meeting, and to chair the selection of the Student Prize Paper Award Recipient. The President designs the program for the Annual Meeting and is responsible for the Executive Committee's decision-making. The Past President chairs the selection of the Heinz Berendes International Travel Award recipient and provides input as needed.

The Treasurer is involved in all Executive Committee activities and is responsible for overseeing the Society's finances, including making purchases, approving expenses, and advising the Executive Committee on financial matters. This member will replace Candice Johnson.

The Member-at-Large participates in all Executive Committee activities. The Member-at-Large elected this cycle will be responsible for leading the Equity Advisory Board. This member will replace Stephanie Leonard.

The International Representative participates in all Executive Committee activities. This representative serves as a link between SPER and the pediatric and perinatal epidemiologic research communities outside of North America, with a goal of increasing SPER membership across the globe. To be eligible, the individual must reside full-time in a country outside North America. This member will replace Neda Razaz.

The Trainee Representative participates in Executive Committee meetings, encourages and facilitates trainee participation in SPER and plans the Advanced Methods Workshop. Meeting and travel costs for the Annual Meeting will be covered for the Trainee Representative. This member will replace Xuanxuan Zhu.

This call for nominations is posted on the SPER website (SPER Call For Nominations). Nominations will be solicited starting December 1st, 2025, and are due by March 13, 2026. Nominations should be submitted online through the SPER website. Self-nominations are accepted. Nominees will be asked to submit a 250-word candidate statement by the above deadline.
